210th	S1237	Prime	Concerns Allows certain beneficiaries of certain deceased retirees to receive retirement allowance

210th	SJR16	Prime	Revokes Joint Resolution No. IV of 1868 which sought to withdraw New Jersey's ratification of the Fourteenth Amendment

211th	S29	Prime	Requires that voting machines produce voter-verified paper record
211th	S30	Prime	Requires posting of a voter information notice called the voter's bill of rights.

211th	S2224	Prime	Exempts veteran's discharge certificate from State's open public records law
211th	S2260	Prime	Allocates money from assessment on hospital operating revenues to support Federally Qualified Health Centers
211th	S2297	Prime	Appropriates moneys to finance the costs of State flood control projects
212th	S1181	Prime	Requires residential mortgage lender to provide debtor with contact information
210th	S34	Co-Sponsor	Appropriates \$27,242,400 in federal funds for bioterrorism preparedness.
210th	S83	Co-Sponsor	Directs BPU to provide for continuation of electrical service for certain residential customers during periods of excessive heat
210th	S153	Co-Sponsor	Prohibits unsolicited telemarketing sales calls to certain customers.
210th	S198	Co-Sponsor	New Jersey Home Ownership Security Act of 2002.
210th	S395	Co-Sponsor	Allows UEZ cities to include certain managerial and prof'l services as projects eligible for UEZ funding
210th	S412	Co-Sponsor	Requires Superintendent to prepare list of State Police employment titles, positions and qualifications
210th	S483	Co-Sponsor	Prohibits firearm possession by persons convicted of domestic violence crime, stalking, or violation of restraining order
210th	S573/S890	Co-Sponsor	Imposes restrictions on future retail sales of handguns
210th	S575	Co-Sponsor	Requires payment of prevailing wages in construction related to Commerce and Economic Growth Commission and EDA assistance
210th	S576	Co-Sponsor	Authorizes an increase in administrative penalties for prevailing wage violations
210th	S1215	Co-Sponsor	Exempts from New Jersey gross income tax the income of victims who died in the September 11, 2001 terrorist attacks against the United States
210th	S1229	Co-Sponsor	Establishes "Amber's Plan" to broadcast public alerts concerning abducted children
210th	S1373	Co-Sponsor	Revises Clean Communities Program and makes available recycling grants to counties and municipalities.
210th	S1558	Co-Sponsor	Grants certain rights, privileges and protections to investigators in the county prosecutor's offices
210th	S1559	Co-Sponsor	Allows qualified UEZ municipalilites to include UEZ funding assistance in order to be eligible for "Main Street New Jersey" program
210th	S1676	Co-Sponsor	Revises receivership statutes.
210th	S1675	Co-Sponsor	Expands municipal power to address abandoned properties
210th	S1788	Co-Sponsor	Establishes Domestic Violence Fatality and Near Fatality Review Board in Department of Community Affairs.

210th	S1965	Co-Sponsor	Expands eligibility for reimbursement from Catastrophic Illness in Children Relief Fund
210th	S2028	Co-Sponsor	Increases membership of the State Board of Mortuary Science of New Jersey.
210th	S2238	Co-Sponsor	Upgrades penalties for theft of identity and the selling, manufacturing, possessing, or exhibiting of false government documents
210th	S2372	Co-Sponsor	Revises procedures for issuance of bail bonds in this State.
210th	S2559	Co-Sponsor	Upgrades crime of luring or enticing a child into motor vehicle, structure or isolated area to a crime of the second degree
210th	S2776	Co-Sponsor	Clarifies various provisions of law establishing the State's "no telemarketing call list
211th	S27	Co-Sponsor	Ends automatic adjustment of campaign contribution limits for committees

211th	S1668	Co-Sponsor	Requires hospital and satellite emergency departments to provide care to sexual assault victims and info about emergency contraception

211th	S1759	Co-Sponsor	Establishes requirements for reducing fine particle diesel emissions from certain vehicles and equipment
211th	S1987	Co-Sponsor	Permits units of local government to limit award of public contracts to business entities that make political contributions
211th	S2052	Co-Sponsor	Prohibits campaign contributions by business entities seeking or holding State contracts in certain circumstances
211th	S2065	Co-Sponsor	Increases the minimum wage
211th	S2106	Co-Sponsor	Requires DHSS to establish special Medicaid admission criteria for long-term care facilities that serve HIV/AIDS patients
211th	S2161	Co-Sponsor	Provides that violation of domestic violence order issued in another jurisdiction would constitute contempt of a domestic violence order in NJ
211th	S2163	Co-Sponsor	Establishes the "School Construction Review Commission
211th	S2334	Co-Sponsor	Social Services Student Loan Redemption Program Act.
